If the competing dog is not an ASCA registered Australian Shepherd and you wish to compete in ASCA OBEDIENCE, you **MUST** obtain an ASCA tracking number from ASCA. A tracking number is good for the lifetime of the specific dog and costs \$10. A service membership (\$10 additional for one year) is required to get a tracking number. YOU MUST SIGN the "AGREEMENT" Section of entry form.

To qualify for pre-entry fees, your entry, payment, and proof of application for tracking form, if applicable, must be received by the trial secretary on or before February 15, 2015 at 8:00 p.m.

REFUNDS: There shall be no refunds for entries withdrawn after the closing date except for bitches that have come into heat, and/or dogs becoming hurt or sick upon receipt of verification from a vet, i.e., a letter or receipt for treatment. No refund is given if a dog or handler is dismissed/excused from competition, regardless of the reason. No refund will be given if the trial cannot open or be completed by reason of riot, civil disturbance, fire, Act of God, public emergency, act of a public enemy, strike or any other cause beyond the control of the Club conducting the trial.

Directions to Trial Location

Travel on "C" street to International Airport Road. Go west (towards inlet), proceed about 1 block,. Turn right (north) into the PartyCraft (639 sign) parking lot. Look right (east) along strip mall.. ACT is beside Guido's Pizza. If you reach SPCA, you went too far.

TRIAL INFORMATION

- ***Due to the limited number of runs, ASCA Registered Australian Shepherds will be given first priority up to the Pre-Entry Closing Date. If pre-entries exceed the number of runs, entries will be accepted in the order of postmark date and a waiting list will be established. Entries on the waiting list will be notified by phone if runs become available.***
- Bitches in season are not allowed on Show premises and may not compete...
- Day-of-show entries (IF available) will be added to the end of the class as they are accepted. Bring your entry form already completed, including height card.
- Please keep your dog on leash when you arrive for the trial and at all times thereafter except when competing. Please keep dogs out of the trial room except when competing.
- A potty area is available at the end of the parking lot, PLEASE pick up all your dogs's poop.
- **Limited crate space available in Room 1. Trial takes place in room 3. Bring whatever you need for your comfort: there is food available nearby. Room 2 is not available for trial purposes. No intensive or abusive training will be tolerated.**

TRIAL SCHEDULES AND INFORMATION

Day of Show entries and move ups only accepted until twenty (20) minutes before the start of trial. Bring tracking number.

A tracking number IS REQUIRED to ENTER this trial. Unless you have an ASCA registered Aussie, you must have a tracking number. Apply by completing the form at:<http://www.asca.org/Portals/812b34ca-1ab9-41bb-9dc9-d7b90411dbdc/trackapp.pdf>
Mail or fax the form, with payment for tracking and service membership asap to ASCA, and include a note that you will be entering this trial.

Should you receive the tracking number before the actual trial date, please inform the trial secretary so the number can be added to your entry form and bring it with you to the trial.

If you do not get the tracking number by trial time, and have applied, we will note "pending" on your entry and after the trial, you will need to confirm your scores with ASCA.. It is best to have the tracking number at the time of trial. If you have not applied before trial, you can apply at the time of trial by providing a completed tracking form application and paying the costs of the service membership and tracking number application BY SEPARATE CHECK made payable to ASCA.
